**COMMUNICATIONS**

Monica A. Smith, Director

The Library gave a number of books in French to the Winterthur/University of Delaware Program in Art Conservation. Mr. Jackson coordinated the donation. We have received a thank you letter in return. The Board will put forth a resolution next month approving the gifted books to the Winterthur/University of Delaware Program in Art Conservation.

Mr. Jackson presented positive remarks and comments made of the Library’s Facebook page.

Ms. Missonellie shared an ad regarding the “solar eclipse party” in Hawthorne on the 21<sup>st</sup> of August at the band shell, with the Library’s logo on it. However, the Library is not sponsoring the event. The Library is only selling the solar glasses on behalf of the Friends of the Library. Ms. Missonellie and other members of the Board were concerned that the Library’s logo was placed on the ad. The Board passed a resolution stating the Library did not consent to having its logo in the ad; the Library is not sponsoring the event, and the Library is only selling the glass for the Friends of the Library.

Ms. Missonellie inquired who Alexandria McLean was; Mr. Jackson stated she is current yoga instructor.

Mr. Metzler discussed the estimate done by Hawthorne Glass & Mirror to repair and replace nine of the Library’s windows which have cracks in them. Further, he mentioned that the Water Department repaired and replaced faucets in the Library.

Ms. Smith mentioned that the auditors requested a meeting with the Finance Committee before the next board meeting. The Finance Committee will be scheduling a meeting with the auditors.

**BUILDINGS AND GROUNDS**

Joseph Metzler, Committee Chairperson

Ms. Smith reported that a patron saw an animal climb under the roof of the children’s section of the Library. However, animal control cannot find any evidence of an animal climbing into the Library.

Mr. Metzler reiterated that situation with the windows and the faucets, stating that the Borough will cover the cost of the faucets and the Library will cover the cost of the windows.

**TECHNOLOGY**

Richard A. Spirito, Jr., Committee Chairperson

Ms. Smith reviewed the work that has been done by NRESC so far. That is, the Library’s equipment has been removed from the BCCLS cabinet, the four PCs in the children’s room have been reconfigured for gaming but they do not have enough memory.

Ms. Smith met with NRESC to develop a replacement schedule for the staff PCs. The goal is to replace four staff PCs before the end of the year. Then replace four more PCs next year and the last two the year after that. It is important to upgrade since the staff PCs are from 2010. NRESC is working on a quote for the replacement PCs. Ms. Smith will have to see if Dell works with the Coop. NRESC estimates \$700-800 per PC. Further, the Library can get Student version of Microsoft Office, however, it does not have Publisher. So, the Library may get Publisher separately for the staff members who need it most.

The Library is waiting on a new quote for the scanners.

Ms. Puzen presented a proposal from ProCopy for either purchasing or leasing a new staff copier. Whichever avenue the Library chooses to pursue, ProCopy would give the Library a floor model for public use. Mr. Metzler asked if ProCopy has a state contract, Ms. Puzen is going to look into that. If they are not, the Library will have to get three bids.

**POLICY**

Vicki Arians, Committee Chairperson

Ms. Puzen has been a notary and is planning on renewing her notary status, and is interested in providing the service to the patrons of the Library. Ms. Smith will present a notary policy for a first reading in September.

Ms. Puzen looked into the question of notary insurance and stated that the notaries at the Borough do not have separate insurance.

The Board said that the Library will pay for Ms. Puzen to be renewed and the money collected from the notary services will return to the Library.

**COMMUNITY PUBLIC RELATIONS**

Jean Mele, Committee Chairperson

Ms. Smith discussed the successful programs held by the Library this past month: from Family Bingo, to Yoga, to a new YA book club for adults.

Mr. Metzler asked about Family Bingo, Mr. Jackson stated that there were over forty people in attendance and that the prizes were pantries, muffins, etc.

Ms. Abbood shared information about the Sussex County Library that she found at the Sussex County Fair. It includes information about the Library’s history and home-bound service.
